- DTCC's depository subsidiary, Depository Trust Company (DTC), processes about \$4 trillion each day in U.S. government and mortgage-backed securities transactions.
- The structured-finance securities include, but are not limited to, collateralized bond obligations, collateralized mortgage obligations and asset-backed securities.
- The processing of these securities generates a detail-rich, multi-field record of each transaction.
- An end-of-day data file containing all transactions for the day is delivered at approximately 12:00AM ET.
